
Sir/Madam,

This is with reference to school application on the subject cited above. I am directed to convey the approval of the Board for Affiliation i.e. Upgradation to Senior Secondary Level as per details given below:

Sl. No.	The school is directed to ensure that :
1	The total number of sections of the school shall be restricted to 14, of which not more than 1/3rd sections may be used for senior secondary classes. In the rooms between 400-500 Sq Ft, the enrollment to be restricted to 32 students per section. Any further increase of section shall require prior approval of the Board, subject to compliance with affiliation bye laws and availability of rooms of 500 sq. ft. dimension.
2	NOC issued by District Education Officer is not acceptable, hence, school is required to submit NOC from appropriate authority of state education department within 03 months.
3	School does not have concrete boundary wall upto 6 feet (video reference time 24:38). School is directed to increase the height of the boundary wall upto 6 feet all around the school campus within 03 months and submit compliance on SARAS with videography.
4	The CWSN toilets available in the school are small. There is no room for a wheelchair/walker to navigate inside the cubicles. The CWSN and general toilets for girls on the first floor have been constructed in the middle of the corridor (video reference time 41:10), resulting in narrowed passage which will restrict mobility. School is required to clear the passage of the corridor and reconstruct the toilets on first floor. Further, as per norms, the school must have provision for separate toilets for CWSN, boys and girls on every floor with sufficient space, proper permanent signage (on the cubicle) and as per norms of RPWD Act and Board's guidelines within 3 months and submit compliance on SARAS with videography.
5	Mathematics lab appears to be under stocked. It does not have adequate seating and storage arrangement. School shall upgrade the lab as per SoP issued by the board within 03 months and submit compliance on SARAS with videography.
6	Composite science lab appears to be under stocked. Bins for biodegradable waste/non-biodegradable waste, sufficient number of sinks, exhaust are not available in the lab. Lab does not have seating arrangement for students. School is required to remove these deficiencies and upgrade the lab as per Sop issued by the board within 03 months and submit compliance on SARAS with videography.
7	The school shall ensure the training of its teachers with CoE Bhubaneswar within 3 months.

Failure to comply within the prescribed time shall invite financial penalty @ Rs. 50,000/- every month until compliance is submitted and shall debar the school from filling the registration and LOC of students class IX to class XII, as the case may be.


The approval of the Board as mentioned above, is subject to the following conditions -

- 1 The school shall be responsible for its genuineness of the documents/ data/ information uploaded by the school. In case of any discrepancies, action will be initiated against the school as per Affiliation Bye -Laws-2018.
- 2 The school shall follow the RTE Act, 2009 and instructions issued thereon by the CBSE/Respective State /UT Govt. from time to time. The school will also abide by the conditions prescribed, if any, by the State Government concerned.
- 3 The School shall apply online for extension of affiliation along with the requisite fee and other documents as per Rule 10.3 of Affiliation Bye Laws.
- 4 The school shall go through the provision of Affiliation and Examination Bye Laws and subsequent amendment therein as well as circulars and guidelines /instructions issued by the Board time to time and keep a copy thereof for reference purpose and is also advised to regularly visit CBSE websites i.e., <http://cbseacademic.nic.in/> & <http://cbse.nic.in/> for updates.
- 5 The school shall renew mandatory certificates from time to time.
- 6 The school shall be solely responsible for any legal consequences arising out of the use of school name/logo/society/trust or any other identity /activity related to running of school affiliated to CBSE. All legal expenses incurred by the Board, if any, arising out of these circumstances, shall be borne by the school.
- 7 Concerned Regional Office is requested to create new email id of school as per direction issued by controller of examination. This E Mail ID is used for communication with CBSE only.
- 8 The school shall not remove the documents and videography links in the mandatory disclosure section of its website.
- 9 The school shall follow the SOPs of the Board for its Laboratories, Library and sports facilities issued by the Board vide circular no 11 dated 04.10.2022.

If the compliance is not submitted within the stipulated 3 months, the Board may enhance the penalty amount and debar the schools from filling up registration/LOC details of students of classes IX to XII, as the case may be, in the next academic session i.e. 2024-25.
